Need to replace the hearse tool for cutting people out of cars, suggested covid money could be used to help the fire dept. with the cost of new things needed.

OLD BUSINESS:

- Marijuana Dispenser Matter/Survey Results (Councilwoman McDonald):  
131 No' on issue  
108 Yes' on issue

The "Board" is not going to repeal the issue about the Cannabis Matter; the Town has no control over the cultivation.

Kerry Trammel, Owner of The Releaf Zone "they will give the cannabis to another processor, it will go to licensed dispensaries in the fall.

A resident who spoke felt the survey could have been done sooner; it was felt that there needs to be something more than the legal notices in the Post Journal; the idea of live streaming meeting to get more people involved.

No resident tried to petition the issue to make it for the ballots;

There is nothing to vote on- it is a dead/closed issue.

NEW BUSINESS:

- "The website needs to be updated, ADA Compliant; people need to be informed, we need the website to be a good website that is maintained. Val-will help to work with a web designer for the town.
