- Volunteer Firefighters/Ambulance Workers Exemption-Matter Tabled- Deputy Supervisor McDonald asked Rep. Davis to address this matter at the County level.

Deputy Supervisor McDonald opened the meeting to the floor:

County Rep John Davis present, announced he will not be seeking reelection as District 16 Representative, introduced Dalton Anthony as candidate.

Todd Stimson, Kerry Trammel presented their concerns regarding Kiantone Dog Laws and concerns with a neighboring dog issue. DCO Abbey had provided information in his report. Dep. Supervisor McDonald reiterated DCO Abbeys recommendations for resolution in the matter. Residents also shared recent criminal activities such as attempted break in as their residence, place of business and vehicle.
