Supervisor Ostrander opened the meeting to the floor: Resident neighbors to the cannabis growing building on Peck Settlement Road appeared to voice concerns of the smell coming from the building, lack of fence screening and air filtration as was conditions of zoning approval. Supervisor Ostrander explained that the Town Board is the wrong venue to address their concerns, however, as a courtesy and as an opportunity to stay informed, would allow them to speak, again reiterating that the Town Board has no power or authority over such matters. Kerry Trammel and Todd Stimson, owners of the ReLeaf Zone and the cannabis growing facility were present, gave their statements as to the status of requirements. Supervisor Ostrander stated that the Code Enforcement Officer oversees these matters.

Resident also brought up topic of creek issues, flooding; Supervisor Ostrander advised that DEC oversees these matters; the Town and Town Highway Department "hands are tied, can be greatly fined if disturb the waterway ecosystem in any manner".

With no further business to come before the Board, Motion Duly Made to Adjourn by Supervisor Ostrander; Seconded by Councilman Landman No Opposition. Unanimously Approved. Meeting adjourned at 8:08 PM
